If legal or other requirements mean you must buy any items you did not specifically ask for, we will explain the reason in writing on the statement we provide describing funeral goods and services you selected. Prior to drafting any contract for goods or services, the responsible party or the decedent's survivor who is handling the funeral arrangements is entitled to receive a copy of any preneed agreement in the possession of the funeral establishment that has been signed and paid for, in full or part, by or on behalf of the decedent.

This fee is for our basic services and overhead will be added to the total cost of the funeral arrangements you select. (This fee is already included in our charges for direct cremations, immediate burials, and forwarding or receiving remains.) This fee includes the following: • Personnel available 24 hours a day, 365 days a year to respond to initial call • Arrangement conference and follow-up visits • Coordinating service plans with cemetery, crematory, and/or other parties involved in the final disposition of the deceased • Clerical assistance in the completion of various forms and permits associated with a funeral • Also covers overhead, including facility maintenance, equipment and inventory costs, insurance and administration expenses, and governmental compliance

PREPARATION OF DECEDENT

Embalming \$795.00

Except in certain special cases, embalming is not required by law. Embalming may be necessary, however, if you select certain funeral arrangements, such as a funeral with viewing. If you do not want embalming, you usually have the right to choose an arrangement that does not require you to pay for it, such as direct cremation or immediate burial.
